- We endeavour to return all Safety Deposits as quickly as possible. To enable us to do this we kindly ask that bank details are supplied to us within 90 days of your event. Failure to do this will result in the loss of your deposit.
- A 25% deposit is required to secure any booking. All deposits are non refundable or transferable. The remaining balance is to be paid six weeks before the event date. Failure to pay your balance will result in the booking being cancelled.
- All payments will be made through bank transfer or personal cheque.
